# **Tracey Forrest**

Chair, Task Force 1: Transformative Technologies — Al and Quantum; Research Director, Transformative Technologies, CIGI

Tracey Forrest is research director of transformative technologies at CIGI. She is a professional engineer and adjunct professor at the University of Waterloo, with domain experience across quantum, energy and technological innovation. She has held senior leadership roles with organizations and initiatives that support the impactful development and deployment of technology.



### **Patricia Fuller**

Chair, Task Force 3: Environment, Energy and Sustainable Development; President and CEO, International Institute for Sustainable Development (IISD)

IISD's president and CEO, Patricia Fuller has more than 30 years of experience in public policy and diplomacy, with a focus on climate change, energy, and trade policy.

Having previously served as Canada's ambassador for climate change, Patricia has built international coalitions and partnerships to advance action on climate change and climate finance. She also led Canada's participation in the Global Commission on Adaptation, including co-chairing the Action Track on Nature-Based Solutions for Resilience. Her diplomatic career has included representing Canada as ambassador to Chile and to Uruguay.

Prior to joining IISD, Patricia headed the Office of Energy Efficiency at Natural Resources Canada and was director general of economic development and chief economist at Global Affairs Canada, where she oversaw the modelling of trade agreement impacts. Earlier in her career, she managed trade policy disputes under the North American Free Trade Agreement and World Trade Organization agreements. Patricia is a senior fellow at the University of Ottawa and holds a master's degree from the London School of Economics.

Based in IISD's office in Ottawa, Patricia is a leader with strong interpersonal skills, building a workplace culture grounded in trust and mutual respect. A strategic thinker and communicator — Patricia is at home getting into the weeds of policy reform without losing sight of big-picture goals.



# **Raquel Garbers**

Raquel Garbers is a CIGI visiting executive from the Department of National Defence, where she held the role of director general, strategic defence policy, since April 2018. **Sophie Arts** 

Task Force 4: Global Peace and Security; Fellow, German Marshall Fund of the United States (GMF), Geostrategy North

Sophie Arts is a fellow with the GMF of the United States, where she leads the organization's research on Nordic and Arctic security and geopolitics. In this role, she covers North American homeland defence against conventional and hybrid threats and cooperation with allies and partners. As part of her portfolio, she also focuses on Russian and Chinese activities in the Arctic region.

Sophie joined GMF's Washington, DC-based security and defence policy team in 2017. Her prior research covered North Atlantic Treaty Organization defence and deterrence, including against cyberthreats and emerging technologies, as well as the alliance's partnership policy. Moreover, she has published on strategic stability and escalation risks in a multipolar world. Sophie previously worked at the Atlantic Council, GMF's Brussels office, Spiegel Online International and Kantar Media. Originally from Germany, she holds an M.A. from Humboldt University in Berlin and a B.A. from the University of Freiburg.



**Justin Bassi** 

Task Force 4: Global Peace and Security; Executive Director, Australian Strategic Policy Institute (ASPI)

Justin Bassi is the executive director of ASPI. From June 2019 to March 2022, he was chief of staff to the minister for foreign affairs and minister for women, Senator the Hon. Marise Payne. Immediately prior to this, Justin was the cyber intelligence mission manager at the Office of National Intelligence, where he led the integration of cybersecurity and critical technologies across the National Intelligence Community.

From September 2015 to August 2018, Justin was the national security adviser to Prime Minister Malcolm Turnbull. He led the team advising the prime minister and cabinet ministers on Australia's national security, defence and international relations. This included responsibility for all areas of security legislation, policy and operations, including counterterrorism, foreign interference, cyberspace, intelligence and border security. Justin was also previously the national security adviser to Attorney-General George Brandis, focusing on Australia's national security legislation, policy and activities, including counterterrorism and telecommunications security.



### Jonathan Berkshire Miller

Task Force 4: Global Peace and Security; Senior Fellow and Director of Foreign Affairs, National Defence and National Security, Macdonald-Laurier Institute

Jonathan Berkshire Miller is an international affairs professional with expertise on security, defence and geo-economic issues in the Indo-Pacific. He has held a variety of positions in the private and public sectors. Currently, he is a senior fellow with the Japan Institute of International Affairs. Jonathan is also a senior fellow and director of the Foreign Affairs, National Defence and National Security program at the Ottawabased Macdonald-Laurier Institute, a senior fellow on East Asia for the Tokyo-based Asian Forum Japan and the director and co-founder of the Council on International Policy. He also holds appointments as a Canadian representative to the ASEAN Regional Forum Expert and Eminent Persons group and as a member of the BMW Foundation's Responsible Leaders Network. Jonathan regularly consults, provides advice and presents to the private sector, multilateral organizations and governments on regional geopolitics. He is a contributor to journals, magazines and newspapers and has been interviewed and quoted on regional security issues across a wide range of media



# **Marjorie Buchser**

Task Force 2: Digitalization of the Global Economy; Consulting Fellow, Digital Society Programme, Chatham House

Marjorie is currently a senior advisor with the United Nations Educational, Scientific and Cultural Organization supporting member states with the development and implementation of robust human-rights-based governance systems for digital technologies. She is also a senior consulting fellow with Chatham House, the Royal Institute of International Affairs, an independent policy institute based in London, UK. For almost a decade, she developed and launched high-priority strategic initiatives for the institute including its Sustainability Accelerator and Digital Society Programme (DSP), the institute's first research program on technology policy. In 2018, she became the executive director of DSP, managing a team of multidisciplinary researchers and overseeing research projects on data flows, artificial intelligence and digital platform governance. Prior to Chatham House, Marjorie worked as an associate director and Global Leadership Fellow at the World Economic Forum in Geneva and New York, where she led the organization's digital innovation projects and managed the Technology Pioneer Programme. She was also a senior strategist at Purpose, a social impact agency, where she developed various advocacy campaigns related to digital inclusion. Marjorie graduated magna cum laude from the Swiss Federal Institute of Technology in Zurich with an M.A. in comparative and international studies as well as an M.A. in political and social sciences from the University of Lausanne.



### **Eleni Diamanti**

Task Force 1: Transformative Technologies — Al and Quantum; Research Director, LIP6 Laboratory, National Centre for Scientific Research (CNRS), Sorbonne University

Eleni Diamanti is CNRS research director at the LIP6 laboratory of Sorbonne University in Paris. She received her Ph.D. in electrical engineering from Stanford University in 2006 and performed her post-doc as a Marie Curie fellow at the Institute of Optics Graduate School in Palaiseau, France, before joining the CNRS in 2009. Her research focuses on experimental quantum cryptography and communication, and on the development of photonic resources and applications for quantum networks. She is a recipient of a European Research Council Starting Grant, coordinator of the Paris Centre for Quantum Technologies, and was awarded the CNRS Silver and Innovation Medals in 2024. She also serves as a member of the European Quantum Technologies Flagship Strategic Advisory Board and is the co-founder and scientific advisor of the start-up company Weling, which specializes in quantum interconnect technology.



# **Ananya Kumar**

Task Force 2: Digitalization of the Global Economy; Deputy Director, Future of Money, GeoEconomics Center, Atlantic Council

Ananya Kumar is the deputy director for future of money at the GeoEconomics Center. She leads the centre's work on the future of money and does research on payments systems, central bank digital currencies, stablecoins, cryptocurrencies and other digital assets. Her analysis has been cited by *The Economist*, the *Financial Times, The Wall Street Journal*, the Federal Reserve, the International Monetary Fund and the World Bank. Ananya previously worked in research assistant capacities at the Carnegie Endowment for International Peace and the Foreign Policy Institute at the Johns Hopkins School of Advanced International Studies (SAIS). She has also worked as a legal analyst at Sidley Austin LLP in New York City. She holds an M.A. in strategic studies and international economics from SAIS, where she was a Merrill Center fellow. Ananya graduated cum laude from Bryn Mawr College with a B.A. in economics and political science.



### Stefan Mair

Task Force 4: Global Peace and Security; Director, German Institute for International and Security Affairs (SWP)

Stefan Mair is director and executive chairman of SWP. His areas of expertise are German and EU foreign and security policy, geopolitical and geoeconomic dynamics, and trade and foreign economic policy. From 2010 to 2020, he was a member of the executive board of the Federation of German Industries. He joined SWP in 1992 as a research associate, eventually serving as a member of the executive board from 2009 to 2010, research director from 2007 to 2009, and head of the Middle East and Africa Research division from 2001 to 2007. He earned his doctorate from the Ludwig Maximilians University of Munich and was a Ph.D. scholar at the Ifo Institute for Economic Research's Developing Countries department.



### Shehnaaz Moosa

Task Force 3: Environment, Energy and Sustainable Development; Director, Climate and Development Knowledge Network (CDKN)

Shehnaaz Moosa's portfolio includes oversight of SouthSouthNorth's (SSN's) finance, delivery and operations hubs; she is the director responsible for CDKN, VCA, CLEAN, ARA and GA LLA, among other projects. Shehnaaz is chair of the Global Resilience Partnership Board, a Global Innovation Fund Climate Advisory Board member, on the Global Transitions Programme Committee and on the Race to Resilience Measurement Advisory Group. She has deep theoretical and practical expertise in delivering complex programs addressing climate change within the African context. Social justice and equity are at the foundation of what informs Shehnaaz's approach to program design and local and global interventions. Prior to joining SSN, Shehnaaz was a researcher and lecturer in the Department of Chemical Engineering at the University of Cape Town. She holds a B.Sc., an M.Sc. and a Ph.D. in chemical engineering. She has the dubious honour of being the first female of colour to obtain a doctorate in chemical engineering in South Africa.



# Peter J. Morgan

Task Force 2: Digitalization of the Global Economy; Senior Consulting Economist and Advisor to the Dean, Asian Development Bank Institute (ADBI)

Peter J. Morgan is senior consulting economist and advisor to the dean at the ADBI and has been with the institute since 2008. He has 23 years of experience in the financial sector in Asia, most recently serving in Hong Kong as chief Asia economist for HSBC, responsible for macroeconomic analysis and forecasting for Asia. Previously, he served as chief Japan economist for HSBC, and earlier held similar positions at Merrill Lynch, Barclays de Zoete Wedd and Jardine Fleming. Prior to entering the financial industry, he was a consultant for MetaSystems Inc. in Cambridge, MA, in energy and environmental analysis, and at International Business Information K.K. in Tokyo, in financial sector consulting. He earned his M.A. and Ph.D. degrees in economics from Yale University. His research interests are in macroeconomic policy and financial sector regulation, reform, financial development, financial inclusion, fintech, financial literacy and financial education. In 2019, he served as the lead co-chair for the Task Force on the Future of Work and Education for the Digital Age for the Think20 process, an engagement group with the G20.



### **Hodan Omaar**

Task Force 1: Transformative Technologies — Al and Quantum; Senior Policy Manager, Center for Data Innovation

Hodan Omaar is a senior policy manager at the Information Technology and Innovation Foundation's (ITIF's) Center for Data Innovation. She leads ITIF's work on US policy in artificial intelligence and quantum technologies across a range of sectors such as health care, education and government. Previously, Hodan worked as a senior consultant on technology and risk management in London, UK, where she audited IT security and management controls at various firms. In addition, Hodan was an economist in Berlin, Germany, where she developed a financial model for the storage of data on a blockchain database. She has an M.A. in economics and mathematics from the University of Edinburgh.



# Giacomo Persi Paoli

Task Force 1: Transformative Technologies — Al and Quantum; Head, Security and Technology Programme, United Nations Institute for Disarmament Research (UNIDIR)

Giacomo Persi Paoli is the head of the Security and Technology Programme at UNIDIR. With more than two decades of experience, he specializes in the implications of emerging technologies — particularly artificial intelligence and cyber — on international peace and security. His recent work focuses on the governance of these transformative technologies, including their impact on arms control, strategic stability and global security frameworks. Giacomo holds prominent advisory roles in shaping the governance of emerging technologies. He is a member of the Expert Advisory Group of the Global Commission on Responsible AI in the Military Domain. Before joining UNIDIR, he was associate director at RAND Europe, where he led the defence and security science, technology and innovation portfolio. He also directed the Centre for Futures and Foresight Studies, focusing on scenario planning and strategic forecasting. Earlier in his career, he spent 14 years as a warfare officer in the Italian Navy, gaining extensive operational and leadership experience.

Giacomo holds a Ph.D. in economics from the University of Rome, a master's degree in political science from the University of Pisa and a master's degree in international affairs and diplomacy at the University of Trieste. Fluent in English, French and Italian, he is a recognized voice in international security, actively supporting multilateral processes aimed at shaping the governance of emerging technologies. He regularly engages with policy makers and publishes research on the security implications of Al and cyber technologies, fostering collaboration across the international community.



# **Tobby Simon**

Task Force 1: Transformative Technologies — Al and Quantum; Founder and President, Synergia Foundation

Tobby Simon is the founder and president of Synergia, a strategic affairs think tank that provides insights and advisory services to industry, military, government and research institutions on advanced technologies, international relations and security. He is a member of the Trilateral Commission and was a commissioner with the Global Commission on Internet Governance. He served as an advisory board member at the Center for a New American Security and the Belfer Center for Science and International Affairs at the Harvard Kennedy School. Tobby has a postgraduate degree in management and is a graduate of the Harvard Business School. He was a research affiliate at the Massachusetts Institute of Technology for five years.



### Izabella Teixeira

Task Force 3: Environment, Energy and Sustainable Development; Former Minister of the Environment of Brazil; Co-Chair of the International Resource Panel of the UN Environment (IRP/UNEP); Member of the High-Level Advisory Board of UN-DESA

Biologist and environmentalist Izabella Teixeira's career includes roles as a technical advisor for the National Secretariat of the Environment and the National Environment Council. She has held various leadership roles, including as a career employee at Ibama, and has served as deputy secretary of the environment for the State of Rio de Janeiro and executive secretary of the Ministry of the Environment. As minister of environment (2010–2016), she achieved record-low deforestation rates in the Amazon and led key environmental initiatives. She has been involved in major environmental negotiations and is currently co-chair of the UNEP IRP and a member of the UN-DESA High-Level Advisory Board. She also serves on the boards of international and national institutions such as the Brazilian Center for International Relations and Instituto Arapyaú. She was a recipient of the UNEP's Champions of the Earth award in 2013.



# Sébastien Treyer

Task Force 3: Environment, Energy and Sustainable Development; Executive Director, Institute for Sustainable Development and International Relations (IDDRI)

Sébastien Treyer is the executive director of IDDRI, since January 2019 (he joined the institute in 2010 as director of programmes). He is also chairman of the Scientific and Technical Committee of the French Global Environment Facility) and member of the Lead Faculty of the Earth System Governance Network. A graduate from École Polytechnique in Palaiseau, France, chief engineer of the Corps of Bridges, Water and Forests and Ph.D. in environmental management, he was in charge of foresight studies at the French Ministry of the Environment, and played an active role in leading the interface between science and policy and scientific programming at the European Commission, the French National Research Agency and territorial actors such as the Seine-Normandy Water Agency.

Previously, he served as Indonesia's minister of national development planning (Bappenas), minister of finance and minister of research and technology. With extensive expertise in economic policy, infrastructure development and global cooperation, he has played a key role in advancing Indonesia's economic transformation and strengthening international partnerships. His work continues to focus on innovation, sustainability and inclusive growth, particularly in the context of multilateral collaboration between G7, G20 and T7 partners



### Sarah Burch

Professor, Department of Geography and Environmental Management, University of Waterloo; Canada Research Chair in Sustainability Governance and Innovation

Sarah Burch is a professor in the Department of Geography and Environmental Management, University of Waterloo, Canada and holds a Canada Research Chair in Sustainability Governance and Innovation.

She is the executive director of the Waterloo Climate Institute, a lead author of the United Nations' Sixth Assessment Report of the Intergovernmental Panel on Climate Change, and helped to lead expert input into the development of Canada's first National Adaptation Strategy. Her research uncovers transformative responses to climate change at the community scale, the political and justice dimensions of energy transitions, and the unique contributions that small businesses can make toward solving these complex challenges. Sarah has served as expert advisor and consultant to the federal government (on climate change adaptation and climate fundamentals education), and dozens of municipalities (on climate change and sustainability action plans).

Sarah holds a Ph.D. from the University of British Columbia and held a postdoctoral fellowship at the University of Oxford. She was named to the Royal Society of Canada's College of New Scholars in 2017, and one of Canada's Clean 50 in 2021.



Cristina Caffarra

Cristina Caffarra is an antitrust economist who was head of the European competition practice of a major firm of economists, leading large teams and appearing as an expert in Europe and across the world on some of the most high-profile cases of the past 20 years. Moving on from consulting, she co-founded the Competition Research Policy Network at CEPR, where she curates and hosts multiple policy discussions. She has been a vocal contributor — speaking and writing extensively — to the global debate on antitrust and regulation of digital markets. She has shaped the European conversation around the role of antitrust as a tool of broader economic policy, by advocating for the integration of antitrust and data protection, and encouraging new thinking around how antitrust can contribute to equitable economic growth. Aaron Shull is the managing director and general counsel at CIGI. He is a senior legal executive and is recognized as a leading expert on complex issues at the intersection of public policy, emerging technology, cybersecurity, privacy and data protection.

Aaron has extensive experience building global networks of experts to enhance engagement with researchers and practitioners drawn from government, academia, industry and civil society. He recently concluded the project Reimagining a Canadian National Security Strategy, which was unprecedented in scale and scope in Canada. It engaged a multidisciplinary network of more than 250 experts to inspire updated and innovative national security and intelligence practices and offered a series of key policy recommendations to assist the Government of Canada in addressing the challenges of a new security environment.

This work was well received by senior officials in government and inspired public conversations with Canada's minister of public safety; the national security and intelligence advisor to the prime minister of Canada; the director of the Canadian Security Intelligence Service; the chief of the Communications Security Establishment; and the privacy commissioner of Canada.

Elizabeth Sidiropoulos is the chief executive of the SAIIA. Her areas of expertise lie in South African foreign policy, Africa and external powers, global governance and South-South cooperation. Her most recent publications include the co-edited volumes *Values, Interests and Power: South African foreign policy in uncertain times* (Pretoria University Law Press, 2020) and *The Palgrave Handbook of Development Cooperation for Achieving the 2030 Agenda* (Palgrave Macmillan, 2021). She is the editor-in-chief of the *South African Journal of International Affairs*, a policy-oriented, peer-reviewed and interdisciplinary forum for discussion on Africa's and South Africa's international affairs. She is a regular commentator in South African and foreign media. In December 2020, she was appointed to serve on the United Nations' second High-level Advisory Board on Economic and Social Affairs. She was on the Secretariat of the T20 Brazil's International Advisory Council. She is one of the co-convenors of the T20 South Africa, an official engagement group of the G20.



Tetsushi Sonobe

Dean and CEO, Asian Development Bank Institute (ADBI)

Tetsushi Sonobe is finishing his tenure at the ADBI, the Tokyo-based think tank of the Asian Development Bank, as its dean and CEO. From April 2025, he is professor at the National Graduate Institute for Policy Studies (GRIPS).

He is a recipient of the Nikkei Book Publication Prize and the Masayoshi Ohira Memorial Prize and the president of the Japanese Association for Development Economics.



### **Antonio Villafranca**

Vice President for Research, Istituto per gli Studi di Politica Internazionale (ISPI)

Antonio Villafranca is in charge of ISPI's) research activities and co-head of the Europe and Global Governance Centre. He has coordinated several research projects funded by Italian institutions (such as the Osservatorio di Politica Internazionale of the Italian Parliament) and by the EU Commission and Parliament (including Gr:een, Rastanews, Trade and Economic Relations with Asia, and Parlatrade). Since 2001, he has taught international relations at the Bocconi University (Milan), where he was lecturer of European economic policy (2015–2018). He was also lecturer of structure of international society at the IULM University.

# **Michael Weisberg**

Bess W. Heyman President's Distinguished Professor of Philosophy; Deputy Director of Perry World House, University of Pennsylvania

Michael Weisberg is an internationally recognized philosopher of science, climate diplomat and academic leader. He is dedicated to bridging science, policy and public understanding. Michael serves as deputy director of Perry World House and editorin-chief of *Biology and Philosophy*, as the Bess W. Heyman President's Distinguished Professor and Chair of Philosophy at the University of Pennsylvania.

Michael is a trusted advisor to small island developing states on critical climate issues, being deeply engaged in international climate negotiations. He has worked closely with Fiji and Palau's negotiating teams at the Conference of the Parties (COP) and also serves as a senior advisor to the permanent representative of Jamaica to the United Nations. His key role for addressing climate loss and damage in developing the "mosaic of solutions" framework contributed to breakthroughs at COP27 and COP28.

Beyond policy, Michael leads the Galápagos Education and Research Alliance. His academic research focuses on scientific modelling and public engagement with science. He has authored *Simulation and Similarity: Using Models to Understand the World* and co-authored *Galápagos: Life in Motion*.
